#### **Approval of Minutes**

### Financial

Mary reported that as of Aug	ust	31, 2021:

Sprinkler repairs totaled almost \$29,000.

### **Budget Approval**

Mary spoke about the 2022 Budget. She also talked about Long-Term Reserve spending and Deferred Maintenance. She mentioned that driveway sealcoating, clubhouse doors, sidewalk concrete repairs and pool furniture are all on the schedules for next year.

Mary made a motion to accept the 2022 Budget of \$1,760,393. Saundra seconded the motion; the board was polled and all approved. **Motion passed 5/0/1** 

### Pool

Mike spoke about the new tile in the showers and waiting for light fixtures and the shower heads to be reinstalled. He also noted that a letter of termination was mailed to American Pools, the current pool company that has done very little to get the pool open.

### **Pool Contract**

Peter made a motion to approve a six-month contract with Candlewood Management Service to service the pool. Annually the cost is \$22,650. John seconded the motion; the board was polled and all were in favor. **Motion passed 5/0/1** 

# **Pool Cat Controller**

Peter made a motion to accept a quote from Candlewood Management Services to install a Cat 5500 Controller – an electronic device that monitors water quality and can report to several locations via Wi-Fi. John seconded the motion; the board was polled and all were in favor. **Motion passed 5/0/1** 

## Saline C 6.0

Peter then made a motion to accept a proposal from Candlewood to install a Saline C 6.0 chlorine generator, adequate for the size of the pool. The motion was seconded; the board was polled and all approved. **Motion passed 5/0/1** 

## **Filter Sand**

Peter made a final motion to accept a quote from Candlewood to replace the sand in the pool filter. The cost is \$827 and mostly labor. John seconded the motion; the board was polled and all were in favor. **Motion passed 5/0/1**
